# Making VCS Affordable

Christian education is now more affordable at Valley Christian School! At VCS, no family has to pay 100% of the cost of education. Through the generous support of our donors and other sources of income, qualified families are able to pay less of what it actually costs to educate a student at our school. We no longer will offer scholarships, but rather a variable tuition amount that is reflective of a family's ability to pay based upon their income. Each year, VCS has offered support to over 60% of our enrolled families. We expect to maintain this commitment. We are moving towards a new way of thinking about tuition awards that reflects our school's commitment to partnering with families that support our mission, while considering their economic conditions. With continued support for annual giving, we pray that this new model of support will help VCS continue to thrive for generations to come. Under the Variable Tuition program, VCS sets tuition for each student based upon what our current third-party financial assessment provider (FACTS) calculates as a family's ability to pay.

## Considerations for Variable Tuition

VCS has used FACTS for several years as a financial management tool. The tuition award amount is based on a "Household Adjusted Income" (HAI) calculation that takes into account many of the factors that make up a family's overall financial picture, including but not limited to:

Income	HVPC member
Household size	Full-time Ministry Leader
Multiple children	Paying full tuition by August 15*

- Students must be enrolled or have an Enrollment Application on file for the upcoming school year to be considered.
- The application for Variable Tuition is separate from the Enrollment Application through the FACTS Tuition Management portal. This fee is non-refundable.\*

\* Tuition is an annual cost paid in full as one payment by August 15th, or in monthly payments from August to May. A \$55.00 FACTS enrollment fee is charged to each family on the 10 month plan and a \$25.00 enrollment fee is charged to each family on the 1 payment plan to administer our tuition accounts. FACTS will bill your account for this fee when your account is finalized. Late fees and returned payment fees may apply.

\*\* The Program Fee is due by July 15th and is non-refundable. It covers the cost of instructional materials, technology, yearbook and programming. All billing is done through FACTS, our tuition company.
